The Office of the Provincial Vice Governor in its review and recommendation, mentioned that:

"Section 16 of the Local Government Code of 1991 (R.A. No. 7160), also known as the General Welfare Clause, provides that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare," further mandating that LGUs shall "promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

Furthermore, Section 458 (a) provides that the Sangguniang Panlungsod, as the legislative body of the city, shall "enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code."

By requiring telecommunication companies in Bacoor City to remove non-active or dangling lines and maintain orderly wiring from distribution points to telecom posts, the City effectively exercises its police power to mitigate public hazards and ensure an organized urban environment.

Thus, this office interposes no objection to the approval and endorsement by the committee of the subject ordinance, provided its implementation remains consistent with national law and policy".

Telecom Posts, and Requiring the Removal of All Non-Active Lines to Ensure Public Safety and Orderly Wiring Management in the City," the undersigned would like to respectfully recommend that a Data Sharing Agreement be established between the telecommunication companies and the City of Bacoor.

This is in relation to the provision stated in Section 8: Monitoring and Enforcement:

"Telecommunication companies covered by this Ordinance shall also provide updated lists of active and inactive subscribers residing or doing business within the City of Bacoor upon request by the City Engineering Office for verification and monitoring purposes."

Given the nature of the information to be disclosed, it may be prudent to include a Data Sharing Agreement in order to ensure the proper handling, protection, and lawful use of subscriber data, consistent with applicable data privacy laws and regulations.

As of this date, no conformity has been received from the Office of the Provincial Legal Officer relative to the review and legal opinion on the proposed ordinance. Nevertheless, in order to comply with existing procedural requirements and to avoid the same from being deemed approved, the Committee hereby submits this report for the consideration of the Honorable Body.

WHEREAS, Article XV, Section 3, Paragraph 2 of the 1987 Philippine Constitution mandates that the State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development;

WHEREAS, the Provincial Government of Cavite, through its Executive Briefing, establishes the overarching mission of a "SAFER CAVITE, BETTER CAVITE", predicated on the belief that proactive leadership and modern safety management improve the quality of lives of its constituents and make the Province more livable;

WHEREAS, the Executive-Legislative Agenda (ELA) 2025-2028 identifies "Peace and Order and Public Safety" as a primary strategic thrust, emphasizing the use of technology and proactive infrastructure to protect vulnerable sectors, including students and educators;

WHEREAS, the ELA 2025-2028 further prioritizes the "Digitalization of Governance and Public Services," supporting the integration of smart security systems to transform Cavite into a modern, tech-enabled, and resilient province;

WHEREAS, there is a recognized need to establish a provincial policy for the installation of CCTV cameras in classrooms to serve as a vital deterrent to bullying, harassment, and other unlawful acts, while providing objective evidence for the fair and transparent investigation of school-related incidents;

WHEREAS, any such safety initiative must strictly adhere to Republic Act No. 10173 (Data Privacy Act of 2012) and National Privacy Commission Circular No. 2024-02, ensuring that the security of students and teachers is balanced with the fundamental right to privacy and the protection of personal information;

NOW, THEREFORE, on motion of Hon. del Rosario, Hon. Pagulayan and Hon. Anacan, duly seconded by Hon. Cantimbuhan and unanimously approved by the Sangguniang Panlalawigan Members present, be it **RESOLVED, AS IT IS HEREBY RESOLVED**, that the Sangguniang Panlalawigan of Cavite hereby encourages the Department of Education and all cities and municipalities in the Province of Cavite to consider the installation of Closed-Circuit Television (CCTV) cameras in classrooms and other strategic areas of schools within their jurisdiction, to help prevent bullying, hazing, illegal drug activities, and other incidents that threaten the safety and welfare of students.
