WHEREAS, after having been reviewed by the said Committees and the Office of the Provincial Legal Officer, it was recommended for approval:

The City Health Office (CHO) or other city-operated health facility may lawfully impose affiliation or training fees on nursing, medical, midwifery and their allied health students undergoing clinical training. However, such fees cannot be imposed unilaterally and any collection must be expressly authorized by a local ordinance enacted by the Sangguniang Panglungsod which present City Ordinance provides.

Affiliation fees for clinical training are ordinarily governed by a Memorandum of Agreement (MOA) or Contract of Affiliation (COA) between the educational institution and the city government or health facility, with the educational institution remitting the fees on behalf of its students. The collection of these fees is principally governed by Joint DOH Administrative Order No. 2013-0034.

To note, Joint DOH Administrative Order No. 2013-0034 is the national regulatory framework governing clinical rotations and internships for health professional students in the Philippines. To exact training or affiliations fees legally, a health facility or City Health Office must execute a formal, notarized Contract of Affiliation (COA) with the student's school before training begins which serves as the sole legal basis for charging, anchoring all collections to standardized national hourly rates and preventing facilities from arbitrarily setting or inflating their training costs.

Regarding actual collection, the order strictly prohibits health facilities from extracting out-of-pocket cash payments directly from individual students. Instead, all affiliation fees must be bundled into the student's tuition and billed directly to the educational institution through official institutional channels. Furthermore, the order enforces an absolute ban on soliciting hidden contributions or "donations", such as demanding medical equipment or office supplies.

NOW, THEREFORE, on motion of Hon. Bautista and Hon. Belamide, duly seconded by Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it **RESOLVED, AS IT IS HEREBY RESOLVED**, that Joint Committee Report No. 608-12SP-2026 of the Committee on Health, Nutrition and Population, and the Committee on Ways and Means be adopted, and that City Ordinance No. 506-2026 from the City of Bacoor be **APPROVED**.

WHEREAS, the implementation of "Car-Free Sundays" provides residents with safer spaces for walking, jogging, cycling, and other recreational activities while helping reduce traffic congestion, improve air quality, promote sustainable mobility, and increase public appreciation for environmentally responsible practices;

WHEREAS, the Provincial Government of Cavite recognizes the importance of fostering healthier, safer, and more livable communities by supporting national policies and programs that promote physical activity, environmental sustainability, and public wellness;

1. Organizing regular community fitness activities, including walking, running, cycling, aerobics, zumba sessions, sports events, wellness campaigns, and other physical fitness programs;
2. Developing, improving, and maintaining accessible green public spaces, parks, plazas, open areas, bicycle lanes, pedestrian pathways, and recreational facilities that encourage physical activity and community engagement;
3. Adopting and implementing "Car-Free Sundays" in appropriate roads or public spaces, subject to traffic management, public safety, and local ordinances;
4. Conducting public awareness and advocacy campaigns promoting healthy lifestyles, active transportation, environmental stewardship, and community participation; and
5. Collaborating with national government agencies, civil society organizations, educational institutions, the private sector, and other stakeholders to ensure the successful implementation of these initiatives.

RESOLVED, FURTHER, that all Local Government Units are hereby encouraged to integrate these programs into their respective Local Development Plans, Annual Investment Programs, Local Public Health initiatives, and Climate Change and Disaster Risk Reduction strategies whenever practicable.
