WHEREAS, after having been reviewed by the said Committee with the technical assistance from the Office of the Provincial Human Resource Management Officer (OPHRMO) and the Office of the Provincial Budget Officer (OPBO), it was ascertained that the Appropriation Ordinance shows substantial compliance with the provisions of R.A. No. 7160 and its Implementing Rules and Regulations;

WHEREAS, the said Appropriation Ordinance is hereby recommended to be operative in its entirety effective on the date of its approval subject to the posting requirement under Section 59 and subject further to the following conditions:

1. The savings certified available by the City Treasurer and City Accountant for supplemental appropriation are free of any obligations or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
2. On Personal Services:
 - a. The funding requirements of five (5) new positions, one (1) City Government Assistant Department Head I (SG23) and four (4) casual Administrative Aide I (SG1) in the City Administrator's Office and other compensation for casual employees shall be subject to the personnel services (PS) limitation prescribed under Section 325(a) of R.A. No. 7160 and the minimum standards and guidelines prescribed by the Civil Service Commission (CSC) pursuant to Section 76 of the Code. Likewise, the authorized salary rate for each position shall be equivalent to the 1st step of the salary grade allocation based on the salary schedule being implemented by the City Government;
 - b. Appropriations for personal services requirements shall be in accordance with pertinent laws/issuances, as follows:

Further, may we reiterate the previous review of the Annual Budget FY 2026 of the City Government that Miscellaneous Personnel Benefits including Terminal Leave Benefits must be transferred to the Office of the City Mayor since these are not considered as programs under Special Purpose Appropriations.

3. The total appropriation of ₱1,184,000.00 for Other Maintenance and Operating Expenses shall include only cost of services, which cannot be classified under any other account name and shall in no case be utilized or used for payment of salaries and/or other remunerations of personnel;
4. The appropriation for the following shall be subject to Sec 335 of the Local Government Code, which provides that "No public money or property shall be appropriated or applied for religious or private purposes":

Subsidy to NGAs	₱ 3,828,428.00
Donations	₱ 78,370,000.00

5. The PPAs for development projects in the amount of ₱149,600,000.00 funded from no less than the 20% of the National Tax Allotment (NTA), prescribed under Sec. 287 of the Local Government Code, shall be subject to the DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020;
6. The appropriation in the amount of ₱8,200,000.00 for the purchase of land shall be subject to Executive Order No. 1035 dated June 25, 1985;
7. The purchase of motor vehicles in the amount of ₱25,800,000.00 shall be subject to DILG Memorandum Circular No. 2022-105 dated August 23, 2022 (Revised Policy Guidelines on Motor Vehicle Purchase/Acquisition, Use, and Rental by the LGUs), DBM Circular No. 2022-1 dated February 11, 2022 (Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Vehicles) and BC No. 2022-1A dated March 1, 2023; and
8. The procurement of supplies, materials and equipment, motor vehicles, infrastructure projects and services, as the case may be, shall strictly comply with the provisions of R. A. No. 12009 and its IRR and any relevant policies issued by the Government Procurement Policy Board (GPPB).

Compliance with all existing laws, rules and regulations shall be the responsibility of the implementing local government unit concerned.

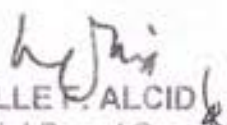
In addition, the said ordinance was endorsed to the Office of the Provincial Human Resource Management Officer (OPHRMO) for review.
