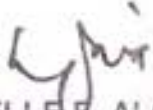
This Committee finds City Ordinance No. 510-2026 from the City of Bacoor within the limits provided for by the Constitution, and the Local Government Code of 1991 (R.A. No. 7160). This Committee also finds no legal impediment for its effectivity.

The Office of the Provincial Human Resource Management Officer in its letter dated 14 May 2026, also expressed no objection to the approval of the said ordinance. The OPHRMO has found that said ordinance may be allowed subject to availability of funds and Personal Services limitations since the position to be created is aligned with the DBM Local Budget Circular No. 137 (Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU) Revised 2021) issued last July 13, 2021.
