WHEREAS, Section 16, Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Local Government Code of 1991 (RA 7160) assigns provincial governments the power to set uniform standards for public services, while cities and municipalities retain authority over local planning, zoning, and day-to-day enforcement;

WHEREAS, Republic Act No. 10611 (Food Safety Act of 2013) designates Local Government Units (LGUs) as primary authorities for regulating street food sales, including ambulant vending, to prevent foodborne and waterborne illnesses;

WHEREAS, Republic Act No. 9296 (Meat Inspection Code of the Philippines, as amended) requires mandatory inspection of food animals before and after slaughter, and prohibits the sale of uninspected or contaminated meat products;

WHEREAS, Executive Order No. 137, s. 1993 devolves meat inspection and regulatory functions to LGUs under the Local Government Code of 1991 (RA 7160), empowering the Sangguniang Panlalawigan to enact ordinances regulating the sale of food products for public consumption;

WHEREAS, Department of Agriculture Administrative Orders No. 20 Series of 2010 (Post-Meat Establishment Control) and No. 05 Series of 2012 (Hygienic Handling of Meat) set standards for storage, labeling, and sourcing of meat products, which are often unmet by unregulated roadside vendors;

WHEREAS, RA 11291 (Magna Carta of the Poor) recognizes the need to balance public safety with livelihood protection, requiring LGUs to support informal workers in transitioning to formalized sectors;

WHEREAS, the Province of Cavite aims to standardize food safety and traffic management across all localities, while empowering cities/municipalities to adapt implementation to their unique geographic, economic, and social contexts;

WHEREAS, informal vendors of aquatic, meat, and poultry products face barriers to formalization including lack of access to training, capital, and designated vending spaces, addressing these gaps is critical to ensuring compliance and sustaining livelihoods;

WHEREAS, coordinated action between the Provincial Government, City/Municipal Governments, and relevant national agencies is necessary to efficiently deliver support services and enforce regulations;

WHEREAS, Roadside sale of aquatic, meat, and poultry products poses significant risks to public health due to exposure to contaminants, pests, and improper temperature control, which can lead to the spread of diseases such as salmonellosis, brucellosis, and other foodborne pathogens;

WHEREAS, the Provincial Government of Cavite recognizes the vital role of food safety in safeguarding the health and well-being of its constituents and visitors;

WHEREAS, street-vended meat products, when left uncovered, are susceptible to contamination from dust, flies, insects, smoke, and other environmental pollutants, thereby increasing the risk of food-borne illnesses;

WHEREAS, the simple practice of properly covering cooked and ready-to-eat meat products using clean and food-grade protective covers significantly reduces the risk of contamination while promoting safe and hygienic food handling practices;

WHEREAS, promoting responsible food vending practices contributes to public confidence in local food vendors and supports the province's commitment to protecting consumer welfare and public health;

WHEREAS, while food safety standards are primarily enforced by the appropriate national agencies and local government units, the Sangguniang Panlalawigan express its support for measures that encourage compliance with sanitary regulations and promote responsible food vending practices throughout the province;

NOW, THEREFORE, on motion of Hon. Bautista, Hon. Reyes and Hon. Malvar, duly seconded by Hon. Austria, Jr., Hon. Gandia, Hon. Jaro, Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it **RESOLVED, AS IT IS HEREBY RESOLVED**, that the Sangguniang Panlalawigan of Cavite hereby urges all street meat vendors operating within the Province of Cavite to properly cover meat products using clean, food-grade protective covers or enclosed display containers while offering such products for sale.

RESOLVED FURTHER, that all city and municipal governments, through their respective health offices, veterinary offices, market administrators, and other concerned agencies, are encouraged to intensify information and education campaigns on food safety, sanitation, and proper food handling practices among street food vendors.

This Committee finds City Ordinance No. 517-2026 from the City of Bacoor within the limits provided for by the Constitution, and the Local Government Code of 1991 (R.A. No. 7160). This Committee also finds no legal impediment for its effectivity.

The Office of the Provincial Human Resource Management Officer in its letter dated 24 June 2026, also expressed no objection to the approval of the said ordinance. The OPHRMO has found that said ordinance may be allowed subject to availability of funds and Personal Services limitations and since it is aligned with the DBM Local Budget Circular No. 137 "Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition, issued on July 13, 2021.
