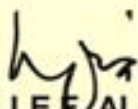

WHEREAS, after having been reviewed by the said Committees, the Office of the Provincial Vice Governor and the Office of the Provincial Legal Officer, it was recommended to be approved, taking into consideration the foregoing observations and recommendations:

The City Ordinance No. 518-2026 was referred to the these Joint Committees for review and evaluation and was subsequently endorsed to the Office of the Provincial Legal Officer (OLO) for legal review.

After a careful and judicious review of the subject Ordinance, the OLO found that the subject ordinance is consistent with the provisions of the Constitution, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, as amended, and other applicable laws, rules, and regulations. It likewise stated that the measure is a valid exercise of the City's authority to enact ordinances in furtherance of the general welfare, particularly in ensuring the accuracy of land survey records used in the processing of tax declarations and the issuance of permits.

After considering the legal opinion and the purpose of the subject ordinance, these Joint Committees find the ordinance to be in order and recognize its importance in promoting accurate property records and supporting the efficient administration of the City's real property taxation and permitting processes.

NOW, THEREFORE, on motion of Hon. Belamide and Hon. Anacan, duly seconded by Hon. Pagulayan and unanimously approved by the Sangguniang Panlalawigan Members present, be it **RESOLVED, AS IT IS HEREBY RESOLVED**, that Joint Committee Report No. 611-12SP-2026 of the Committee on Ways and Means, and the Committee on Land Use, Zoning, Urban Development and Housing be adopted, and that City Ordinance No. 518-2026 from the City of Bacoor be **APPROVED**, taking into consideration the foregoing observations and recommendations.

WHEREAS, after having been reviewed by the said Committee, the Office of the Provincial Vice Governor and the Office of the Provincial Legal Officer, it was recommended to be approved, subject to amendments:

In the course of its deliberation, the Committee took into consideration the review and recommendation of the Office of the Provincial Vice Governor.

The review states that the proposed ordinance seeks to amend City Ordinance No. 469-2025, which was previously declared valid and approved by the Sangguniang Panlalawigan through Resolution No. 4224-2025 dated 06 November 2025.

It was likewise noted that the proposed amendment was prompted by a request from a business owner who pointed out that the existing ordinance does not specifically address businesses operating under a work-from-home arrangement. The request urged the Sangguniang Panlungsod to clarify the coverage of the ordinance to ensure the fair and consistent application of solid waste management fees.

The Office of the Provincial Vice Governor further observed that the Sangguniang Panlungsod has the authority under Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to enact ordinances for the protection of the environment and to establish an efficient system of solid waste management. This authority is likewise supported by Republic Act No. 9003, or the Ecological Solid Waste Management Act of 2000, which designates local government units as primarily responsible for the implementation and enforcement of solid waste management programs, including the imposition of reasonable fees necessary for their implementation.

*While finding the proposed ordinance to be within the authority of the City Government of Bacoor, the Office of the Provincial Governor recommended that the term **"home-based business"** be removed from the proposed amendment and that the **"work-from-home"** category be more clearly defined to avoid ambiguity in its application and enforcement.*

The Committee finds the foregoing recommendation to be reasonable and believes that the suggested revisions will provide greater clarity and promote the proper implementation of the ordinance.

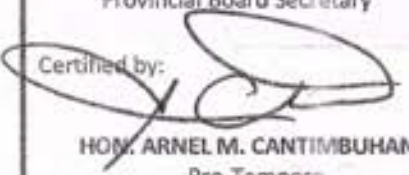
