CITY ORDINANCE NO. 492-2026 SERIES OF 2026 ENTITLED "AN ORDINANCE PROHIBITING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES IN THE CITY OF BACOR OR PARTS THEREOF, WHENEVER A STATE OF CALAMITY IS DECLARED BY THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (BDRMC) PROVIDING PENALTIES FOR VIOLATIONS HEREOF, AND FOR OTHER PURPOSES"**
